Where there are fewer than ninety (90) young lawyers in a District, the signature of ten percent (10%) shall be sufficient. The counties comprising the Districts are:

- 6 McDowell & Mingo (2 required to nominate)
- 7 Boone, Logan & Lincoln (4 required to nominate)
- 8 Kanawha (10 required to nominate)
- 9 Raleigh & Wyoming (5 required to nominate)
- 10 Mercer, Summers & Monroe (3 required to nominate)

The Young Lawyers Section consists of all State Bar members who have been in the practice of law for less than 10 years and/or are 35 years of age or younger.

A nominating petition is located on the back of this page. A copy of the nominating petition can also be found on The State Bar website under the Members tab. When signed by the requisite number of members, the petition must be received, by mail, email or fax no later than midnight February 11, 2014 by the Executive Director, The West Virginia State Bar, 2000 Deitrick Boulevard, Charleston, WV 25311-1231; caseya@wvbar.org; or fax 304.558.2467. If multiple copies of the petition are used, they must be sent together. Note that the By-Laws states, in pertinent part: No member shall sign more than one nominating petition in any year.
