THE WEST VIRGINIA STATE BAR INSTRUCTIONS FOR FORMING A LEGAL CORPORATION (L.C.)

- 1. Each application to form a Legal Corporation shall be submitted to the West Virginia State Bar and accompanied by a \$50.00 application fee. (Rule 11.02(a))
- 2. The corporation's name must contain the last name or names of one or more of its shareholders, or lawyers associated with the partnership or legal corporation and contain the words "Legal Corporation" or the abbreviation "L.C." (Rule 11.04(2))
- 3. Each application shall be signed by an incorporator of the Legal Corporation. (Rule 11.02(a))
- 4. The application shall contain the office address, email address, telephone number and facsimile number for the contact person designated by the applicant. (Rule 11.02(a))
- 5. If the legal corporation has shareholders or other lawyers associated with the entity who are not admitted to practice law in West Virginia, the legal corporation must (a) designate one or more licensed West Virginia lawyers associated with the LC who shall be responsible for compliance with the unauthorized practice of law provisions of the West Virginia Rules of Professional Conduct, and (b) certify that the corporation has sufficient policies and procedures in place to prevent the unauthorized practice of law. (Rule 11.02(b))
- 6. The legal corporation must provide written disclosure that the corporation has professional liability insurance or a designated, segregated fund for the satisfaction of judgments against the corporation, its shareholders and employees for acts, errors, and omissions occurring in the practice of law (Rule 11.04 (b)).
- 7. All approved LCs must file a renewal application with the West Virginia State Bar with the applicable \$50.00 renewal fee on or before November 1 of each year. (Rule 11.06)
