

 - · Access to parking




REMOTE VICTIM OUTREACH PROJECT

Pilot project started in 2021 with four counties. Expanding in 2022.


Office of Violence Against Women grant funds are used to purchase small video conferencing units (VCUs) and document cameras for victim service agencies that attach to the larger VCUs in the courtroom.

All of the VCUs feature document cameras, a screen for viewing, a camera, and a microphone, which makes it possible for remote hearings to take place while victims stay physically separated from their alleged abusers.



The Administrative Office provides training for magistrates and judges, as well as educational guides that are distributed to facilities to provide guidance to those who use the remote sites.

Personal Safety Orders

When is it needs

When someone is repeatedly causing, attempting to cause, or threatening bodily injury to someone who is not a family or household member.

It may include stalking and sexual offenses (such as sexual assault), and/or repeated credible threats of bodily injury when the person making the threats cause another person to reasonably fear for his or her safety.

What is a Personal Safety Order?

An order that identifies who needs to be protected, who is accused of harmful acts, and what the accused person can and cannot do.

Who can get a Personal Safety Order?

Any adult and/or child who is in reasonable fear for his or her safety from another person. A relative may go to court on behalf of a person who is mentally or physically unable to seek help.

If an order is violated, contact law enforcement immediately

Step 1: File a Temporary Protective Order

All magistrate courts in West Vaginia have forms han can be used to request a Temporary Personal Safety Order. The form is called a petitione. The person who files it is called the petitioner. The person who is accused is called the reproduct and will have an opportunity to respond to the petition. Petitioners and respondents are parties to the case.

There are two ways to file a petition

- 1. Petitioners can go to court on their own in
- person.

 2 Petitioners can call CONTACT Sexual Assault Help Center (SAHC) at (304) 234-1783 and set up an appointment to file the petition remotely with the help of a sexual assault victim advocate. This service is provided from \$0.00 a.m. to \$0.00 p.m.

Either way you can call (800)884-7242 the 24-hour hot-line and speak with an advocate that can assist you.

Magistrates are on duty from 9 a.m. until 5 p.m. Monday through Friday to review petitions and issue Temporary Personal Safety Orders.

Petitioners must include on the form the most recent events of violence or theasts of violence, but past events can also be included. Petitioners must provide the name and address of the responder involved. Petitioners also must provide their own name and address, but anyone teeking a person aftery order can request that their own address be kept confidently.

Magistrate Court Temporary Hearing

Once a petition is filed, a magistrate holds an emergency hearing and asks the petitioner questions. Petitioners can participate in this hearing remotely from the CONTACT Sexual Assault Help Center.

If there is evidence of an immediate and present danger, the magnituste will issue a Temporary Personal Safety Order. The magnituste will schedule a final hearing, and the magnituse's order will last only until that hearing. Magnituse's end copies of these orders electronically to law enforcement agencies.

If the magistrate denies the petition, the petitioner can appeal to circuit court using forms available from magistrate clerk's office.

Temporary Personal Safety Orders are effective statewide and in other states. All orders tell respondents not to abuse, hassas, stalk, thresten, infamidate, or cause fear of boddy injusy to those named in the orders. Temporary Personal Safety Orders can include other stipulations if they are necessary to protect somenoe's safety, such as whether a respondent can go near a business, school over a beautiful.

- Capture electronic fingerprints, direct indictments, and pleas of information at time of arrest.
- Digital prints enhance the quality, completeness, and accessibility of criminal records.

Online Payment Portal

Available July 1, 2022

The online payment portal will be available for offenders to pay for criminal assessed tickets or cases where the defendant has fines, fees, or costs due to the court.

At this time, there will be <u>no</u> online restitution payments accepted.

House Bill 4712 capped the payment plan option for offenders:

5 years in circuit court

3 years in magistrate court
