# **Shepherdstown Regional Meeting Presenter Bios**

#### J. Zak Ritchie

Zak's practice focuses on complex commercial and government litigation. He also frequently handles appeals in state and federal courts. Zak founded the firm after working in private practice and as assistant solicitor general in the Office of the West Virginia Attorney General. As an assistant solicitor general, Zak concentrated on federal regulatory challenges in the energy and environmental sectors, defended state laws from constitutional challenge, and frequently appeared before the state's highest court. In litigation over federal rulemaking before the U.S. Court of Appeals for the D.C. Circuit, Zak coordinated the state's legal strategy with an array of national trade groups, including the U.S. Chamber of Commerce, the National Federation of Independent Business, and the National Mining Association, among others. Since joining the private practice, Zak has also developed a growing commercial and appellate practice concerning disputes over corporate governance, shareholder derivative law, and insurance coverage, as well as the defense of matters involving lawyers and their firms.

A native of the Mid-Ohio Valley, Zak graduated from West Virginia Wesleyan College and West Virginia University College of Law. Following law school, Zak served as a law clerk to the Hon. John T. Copenhaver of the U.S. District Court for the Southern District of West Virginia and the Hon. Stephanie D. Thacker of the U.S. Court of Appeals for the Fourth Circuit.

#### Anthony J. Majestro

Anthony J. Majestro is the Managing Member of Powell & Majestro, PLLC. West Virginia. Mr. Majestro is a *summa cum laude* graduate of West Virginia University (1986) and a *cum laude* graduate of Georgetown University Law Center (1989). Mr. Majestro is licensed to practice law in West Virginia and various federal district and appellate courts. Mr. Majestro was selected as a Harry S. Truman Scholar in 1984 and served from 1989-1990 as a law clerk to the Honorable Thomas A. Clark of the United States Court of Appeals for the Eleventh Circuit in Atlanta, Georgia. Mr. Majestro concentrates his practice in prosecuting complex litigation, focusing on consumer fraud and defective products, including defective drugs and medical devices.

In the course of his practice, Mr. Majestro has served as class counsel, lead counsel, liaison counsel and in leadership roles in a number of state and national class actions, mass torts, and other complex cases. Mr. Majestro has developed an extensive appellate practice and has numerous appellate victories in state and federal appellate courts across the country, including a unanimous decision on the merits from the Supreme Court of the United States. Mr. Majestro regularly serves as appellate counsel and also represents state and local officials and agencies in trial and appellate litigation.

#### Rachael L. Fletcher Cipoletti

Rachael L. Fletcher Cipoletti is Chief Lawyer Disciplinary Counsel for the West Virginia Office of Lawyer Disciplinary Counsel. She has been with the ODC since 2002 and became Chief Disciplinary Counsel in 2008. Rachael also serves as Special Judicial Disciplinary Counsel for the Judicial Investigation Commission. Rachael is a frequent lecturer on ethics and professionalism for the West Virginia University College of Law, the WV State Bar, and the American Bar Association.

Rachael is admitted to practice before the Supreme Court of Appeals of West Virginia, United States Southern District of West Virginia, United States Northern District of West Virginia, United States Court of Appeals for the Fourth Circuit and the Supreme Court of the United States of America. Rachael was previously an attorney with Legal Aid of West Virginia. She graduated with a Bachelor of Arts Degree in Psychology from West Virginia University and also earned her Juris Doctorate from West Virginia University. She currently serves on the Future of the Law Committee for the WV State Bar, is the ODC liaison to the WV Judicial and Lawyer Assistance Program, serves on the Supreme Court of Appeals of West Virginia Task Force on Lawyer Well-Being, and serves on the ABA's standing committee for the Commission on Lawyer Assistance Programs Consortium on Professionalism Initiatives. ## Judge Debra McLaughlin, Twenty-Third Judicial Circuit

Judge Debra McLaughlin was raised in Manassas, Virginia. She has been a resident of Morgan County from 1999 until 2019 where she practiced law and raised a family. In 2019, she relocated to Berkeley County to accommodate her 16-year-old's education in the dual enrollment program between Shepherd University and St. Maria Goretti High School.

She has a 1990 bachelor's degree in sociology with a concentration in criminal justice and psychology from St. Francis University in Loretto, Pennsylvania, where she was an Honors Program graduate. She has a 1993 law degree from the University of Kansas School of Law.

Judge McLaughlin was an associate at the law firm of Bochetto & Lentz and later a Katherman & Heim from 1994 to 1999. In 1999, she joined the firm of Harmison & Savasten in Berkeley Springs. Shortly thereafter, she became a part-time assistant prosecutor for Morgan County. In 2002, she was appointed to the office of Morgan County Prosecuting Attorney; she was elected to the position in 2004 and re-elected in 2008, 2012 and 2016.

Governor Jim Justice appointed her to the bench in the Twenty-Third Judicial Circuit (Morgan, Berkeley and Jefferson Counties) in August 2017 and she served until May 2018. He appointed her again in March 2019. Between May 2018 and November 2018 she was a solo practitioner practicing in criminal defense and abuse and neglect. Between December 2018 and March 2019 she was an assistant Jefferson County prosecutor.

### Judge Steven Redding, Twenty-Third District

Judge Redding is a native of New Carrollton, Md. He has a bachelor's degree in government and politics from the University of Maryland and a law degree from the University of Baltimore School of Law, where he graduated with honors and was a member of the Law Review.

On Feb. 22, 2018, Governor Jim Justice appointed him to the bench in the Twenty-Third Judicial Circuit (Berkeley, Jefferson and Morgan Counties) and he was elected to the seat in May 2018.

Judge Redding attended law school at night while starting his family and working full-time on the Prince George's County, Md., Fire Department. After he became a lawyer, he continued to work at the fire department as an attorney and firefighter until ending his firefighting career, in 1997, as a Lieutenant. He then served as an active member of the South Berkeley Volunteer Fire Department until the end of 2022. He was awarded a Medal of Valor for rescuing a small child from an apartment fire.

Judge Redding entered private practice in 1990 and concentrated on insurance and medical malpractice defense law before becoming a partner at Franklin & Prokopik, PC., managing the firm's Hagerstown office. He took four years off from the practice of law to recover from injuries sustained in a serious car accident. He returned to work part-time in 2011 as a guardian ad litem, representing children in abuse and neglect cases, and returned to full time practice in 2013, continuing his representation of children, as well as practicing criminal defense. In February, 2017, Judge Redding joined the Public Defender Corporation for the Twenty-Third Judicial Circuit, where he worked until his appointment to the bench.
